

## **PROFESSIONAL GRAPPLING BOUT CONTRACT**

This contract is made this 03 day of November, 2022, by and between Isaac Payne of the City of Rexburg and State of Idaho, and \_\_\_\_\_ of the City of \_\_\_\_\_ and State of \_\_\_\_\_, a grappling competitor (hereinafter "Contestant"). This contract is subject to the laws of the State of Idaho.

Parties agree to abide by all rules agreed upon and clarified before the bout.

### **I. Bout**

Contestant agrees to enter into a submission grappling contest to be held at Rexburg Idaho, on the 3<sup>rd</sup> day of December, 2022. The bout will be The Romance Theater in Rexburg Idaho.

This contest shall be at a weight not over 160 pounds, said weight to be taken on certified scales. Contestant agrees to appear at the weigh-ins for the bout which shall take place on the 2<sup>nd</sup> day of December, 2022 at 4 p.m. at Rexburg, Idaho.

Contestant agrees to arrive to the weigh-in at the time agreed upon and to the bout two hours before the time set for the event. Contestant understands that failure to make contracted weight and/or weigh in inside of their weight class may result a forfeit.

Contestant understands that reporting to either event after the time set may result in a forfeit.

### **II. Compensation**

Promoter shall pay Contestant and Contestant shall accept a purse in the amount of \$500 Dollars if Contestant places first in the bracketed competition. This does not include exhibition/super fights.

### **III. Assumption of Risk**

The Contestant understands and agrees that by participating in this bout, Contestant is engaging in an abnormally dangerous activity which subjects the Contestant to risk of severe injury or death. The Contestant with full knowledge of risk, nonetheless, agrees to enter into this agreement and hereby waives any claim that the Contestant or Contestant's representatives or heirs may have against the event, Promoter, or Anaconda Fight Wear as a result of any injury the Contestant may suffer as a result of Contestant's participation in this contest.

### **IV. Indemnification and Release**

The parties, jointly and severally hereby indemnify, hold harmless, release and forever discharge the event, Promoter, PAC Jiu-Jitsu, Anaconda Fight Wear each of their members, agents and employees in their individual, personal and representative capacities against any and all claims, suits and actions, known or unknown, brought against the persons named in this paragraph by reason of this agreement and all other matters relating thereto, and against any and all expenses, damages, charges and costs, including court costs and attorney fees which may be incurred by the persons and entities named in this paragraph as a result of said claims, suits and actions.

**This contract shall be submitted 10 business days prior to the bout.**
